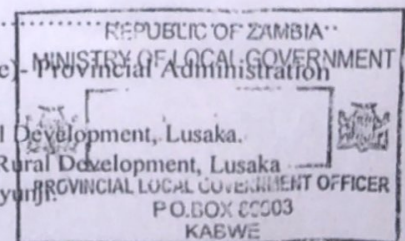
Has been **approved** by the Provincial CDF Committee, Provincial Administration subject to the following conditions:
